

## AZITRA: NTH-1201 STUDY NETHERTON SYNDROME

What is the purpose of this program?

Deciding to participate in a clinical trial is an important decision for patients and their families. When entering a clinical trial, the expense required to arrange travel to and from a study site may be considered a barrier to participation. This Program eliminates that barrier.

NORD's Clinical Trial Travel & Lodging Assistance Program provides individuals enrolled in the NTH-1201 study with financial assistance and reimbursement for travel and lodging related to participation in this study.

#### Who is eligible for this program?

If you are participating in NTH-1201 study, the coordinator at your study site will refer you to NORD.

- A NORD Patient Services Representative will contact you to begin the process for arranging your travel and lodging for your study site visits. This will occur after the study consent form has been signed and/or the site coordinator sends your referral to NORD.
- NORD will book and prepay your travel and lodging costs and will review with you the process for reimbursement of some additional out-of-pocket costs you may encounter during your study participation such as meals.

### About the program

Azitra has contracted with The National Organization for Rare Disorders (NORD) to administer a clinical trial Travel and Lodging Program that will provide financial support and concierge travel arrangements for individuals participating in the Netherton syndrome NTH-1201 study.

- <u>Travel</u> NORD will arrange and prepay the cost of airfare for the study participant and one (1) caregiver/support person.
  - Airfare standard economy rate
  - Baggage one (1) carry-on & up to two (2) checked bags/person allowed
- <u>Hotel</u> NORD will book and prepay lodging.
- <u>Ground transportation</u> (Uber/Lyft, or Taxi) will be reimbursed upon participant provision of receipts:
  - Between home and departure airport
  - Between airport and hotel
  - Between hotel and study site
- <u>Parking</u> (airport or hotel & study site) will be reimbursed upon participant provision of receipts.
- <u>Mileage</u> will be reimbursed for study participants traveling using their personal vehicle to travel from home to airport or round trip from home to study site. Mileage will be reimbursed at the current U.S. IRS Business reimbursement rate.
- <u>Meals</u> a stipend of \$85/day will be provided via a prepaid debit card to cover meal expenses for the study participant and one (1) caregiver/support person.
- An additional stipend of \$25 for 1-2 day study visits and \$150 for 15 day visits, to cover the expense of one (1) in-room movie rental/day (when such service is available).

#### Expenses will be paid within established program limits.

Requests for assistance outside these guidelines will be reviewed by NORD and Azitra for individual consideration.

The following items are NOT reimbursable:

- Rental cars
- Alcohol or tobacco products
- Personal services (e.g. laundry, dry cleaning, personal toiletries, etc.)
