

# Myasthenia Gravis (MG)

## Patient Assistance Programs



### What is the purpose of this program?

NORD's Myasthenia Gravis (MG) Patient Assistance Programs offer eligible individuals diagnosed with myasthenia gravis financial support when faced with limited resources to pay for out-of-pocket healthcare costs including:

- Health insurance premiums, deductibles, copayments and coinsurance costs for the care and treatment of Myasthenia Gravis including:
- Medical appointments and consults
- Physician prescribed FDA-approved medications
- Physician prescribed laboratory and diagnostic tests
- Physician prescribed physical, occupational and/or speech therapy

### Who is eligible to apply for NORD's Myasthenia Gravis Patient Assistance Programs grants?

These programs are designed to help patients who:

- Are a United States citizen or US resident of six (6) months or greater with evidence of residency such as a utility bill showing the patient's name and address
- Have a diagnosis of MG
- Fall within the Program's financial guidelines and adhere to application requirements that are set in advance by NORD

### What kinds of assistance can I request from NORD?

NORD's programs can assist eligible individuals/families with expenses in a number of categories:

- The Myasthenia Gravis Premium and Copay Program assists eligible individuals who have health insurance with funding to cover health insurance premiums, deductibles, copayments and coinsurance costs associated with the care of myasthenia gravis.
  - Some examples of these expenses include:
    - medical expenses paid toward health insurance premiums and/or deductible
    - copayment for a medical office visit
    - out-of-pocket cost for medications prescribed by your physician to treat myasthenia gravis
    - a coinsurance payment for a physician prescribe laboratory or radiological exam
    - a copayment for physical, occupational or speech therapy
- The Myasthenia Gravis Medical Assist Program assists eligible individuals who are uninsured, or for whom coverage has been denied with out-of-pocket costs for medical expenses.
  - Some examples of these expenses include:
    - medical visits
    - laboratory and diagnostic testing
    - medications and therapies specific to myasthenia gravis related diagnosis

Additionally, mileage for travel to and from an MG related medical appointment may be reimbursed in this program.

## FAQ

### What is NORD?

The National Organization for Rare Disorders (NORD), a 501(c)(3) organization, is an independent nonprofit dedicated to the identification, treatment and cure of rare "orphan" diseases through education, advocacy, research and patient service programs.

NORD was founded by families struggling to obtain access to treatments and whose advocacy for change led to the passage of the Orphan Drug Act in 1983. NORD assists eligible patients (those with medical and financial needs) in affording the treatments and medical services their healthcare professionals have prescribed.

Funding for NORD comes from a variety of sources including corporate donations, foundation grants, public contributions and membership dues.

### What is the application process?

Awards are granted on a first come, first served basis. Patients may be referred to the program by their health care provider, their case managers, or they may self-refer. The RareCare® Patient Services Representative will guide the applicant through the application process, verify eligibility for inclusion in the Myasthenia Gravis Program(s), determine financial eligibility using our Electronic Income Verification System (EIV) and award assistance.

### What happens if an applicant does not meet the criteria of the Electronic Income Verification?

The RareCare® Patient Services Representative will offer to e-mail, fax, or mail the brief program application and disclosure forms to the patient. The applicant may then complete the application, sign the disclosure form, provide the appropriate financial documentation to verify financial need, and return them via fax, email, or USPS mail.

### How does NORD demonstrate compliance with regulations required of charities?

- NORD independently designs its patient assistance programs based on the needs of specific patient communities.
- No pharmaceutical company or donor controls or influences our programs.
- Our patient assistance decisions are based on consistently applied financial eligibility criteria and diagnosis only.
- Patients have their choice of health care provider, treatment and treatment location, and can make changes at any time.
- Patients' privacy and well-being are priorities at NORD. We do not share or provide patient names or data with donors, nor do we disclose or identify donors to patients. Patients are able to make the choices that are best for them because NORD's assistance covers all FDA-approved products available for a diagnosis. Our programs also help with more than medication: patients can use their funds to pay for other physician prescribed services related to their diagnosis such as, laboratory and diagnostic testing, physical and occupational therapy, durable medical and adaptive equipment, and travel to medical appointments.

### Once a patient is accepted into the assistance program(s) how long are they eligible?

Premium, Copay and Medical Assist awards are issued for a calendar year.

Patients are encouraged to reapply annually if continued assistance is needed.

### How does the payment or reimbursement process work?

Premium, Copay and Medical Assist awards may be prepaid by NORD with appropriate documentation or reimbursed to the patient in accordance with appropriate receipts and documentation.

All claims submitted for reimbursement must be provided within 30 days of date of service and include receipts or other evidence of payment, such as a credit card statement.

Reimbursements will be made within ten (10) business days of receipt by NORD.
